The Child Death Overview Panel will be using an electronic management system called **eCDOP** moving forward, to manage child deaths in our area.

This will mean you will be notified of a child death, requested to complete a reporting form and invited to panel meetings all electronically using the eCDOP system.

From the 01 April 2019 all notifications will need to be submitted electronically.

Are you aware of a child death and want to notify the Child Death Overview Panel?

The way child deaths are notified to the Child Death Overview Panel has changed.

We are now using an electronic management system called 'eCDOP'

Previously, you may have been asked to download a 'CDOP Form A – Notification of Death', fill in the relevant sections and email to the CDOP Co-ordinator. This system has been replaced.

Now, if you would like to submit a notification go directly to the following link:

Input the details and press the green submit button. This system is completely secure and the submission will go directly to the CDOP Co-ordinator to generate a case.

This link is for all notifications of death for Stoke-on-Trent and Staffordshire children.

Submitting a Child Death Review Reporting Form (previously Form B)

The way child deaths are notified and accessed to the Child Death Overview Panel has changed.

We are now using an electronic management system called 'eCDOP'

Previously, you may have been asked to submit further information surrounding your involvement with a child and their family via a Form B request from the CDOP Co-ordinator. This system has been replaced.

To submit a 'child death review reporting form' (previously Form B) follow the link in the email request you receive. Log in. Initially, you will receive a temporary password to eCDOP, and then you will be prompted to change password. A two-factor code will be sent to your email address – copy and paste into the log in page.

You will be able to complete and submit the 'child death review reporting form' by clicking onto 'Messages' and following the link to the reporting form. When complete submit and details will be attached to the case.

....Accessing a 'notification of death' from eCDOP

The way child deaths are notified and accessed to the Child Death Overview Panel has changed.

Previously, you may have received a 'notification of death' (pre, Form A) from the CDOP Co-ordinator. This system has been replaced.

To view the notification you need to log on directly to eCDOP. Follow the link in the email you receive.

Initially, you will receive a temporary password. When you have logged into the system you will ask you to create a new password.
