Update from the Board

The Board attended a development day on January 23, led by Lorraine Parker, National Policing Coordinator for the Multi Agency Child Safeguarding Reform and Mark Gurrey, Independent Chair of Wiltshire Safeguarding Vulnerable People Partnership and a member of the National Child Safeguarding Practice Review Panel. Mark recently conducted a review into the Stoke-on-Trent and Staffordshire Safeguarding Arrangements which was commissioned by the Department of Education Children's Commissioner for Stoke-on-Trent, Eleanor Brazil, and is intended to be linked to her overall review of children's services. Mark presented recommendations that the partnership review the governance and accelerate the arrangements for the delivery of independent scrutiny, the quality assurance work and to set out how rapid reviews and individual case reviews are conducted so that together they can enable the safeguarding partners in Stoke-on-Trent and Staffordshire to have more detailed knowledge and greater influence over the delivery of services to children and families in their areas.

The purpose of the day was to discuss the statutory responsibilities of Working Together 2018, the role of the board with its partners and its geographical positioning with regards to the escalation and resolution process. Discussions were held with regards to redirecting the Boards attention to assessing the quality and assurance of the children's systems, focusing on solutions rather than process and developing one multiagency safeguarding arrangement.

A further development workshop with the Board and Partnership took place on February 11 which led to detailed discussions about the responsibilities of the two governance groups along with identifying priorities across all agencies leading to a multi agency business plan focusing on lessons learnt and direction of travel. Further work will now continue on the creation and implementation of the plan. More updates to follow.

Review of Restraint at Werrington Young Offenders Institute Update

The review of restraint at Werrington Youth Offending Institute Task Group have developed its Terms of Reference which outline its core aims. These include helping to ensure that relevant agencies in Stoke-on-Trent and Staffordshire work together to promote the welfare and safety of all children and young people in secure settings, raising the awareness of how to improve current practice, fulfilling statutory safeguarding children responsibilities.

The SSCB Review of Restraint Task Group will be responsible for scrutiny and provide assurance to the Partnership and Board around the appropriate use of restraint in accordance with national guidance. The group will ensure staff in the secure estate are trained in behaviour and de-escalation techniques and put in place appropriate monitoring arrangements to protect vulnerable young people.

The group is attended by representatives from the Board, Werrington Young Offenders Institute, children's social care, education service, health service, Staffordshire's Youth Offending Service and the SSSCB business team.

Child Death Overview Panel Update

The Child Death Overview Panel (CDOP) presented an update to the partnership on Tuesday, January 21 outlining lessons learnt from reviews, areas of concern and plans for the coming year.

New arrangements for reviewing child deaths are evolving which will be overseen by panel members consisting of Designated Doctor for Unexpected Deaths, CDOP Nurse Practitioners and panel coordinator.

CDOP members within the paediatric settings shared concerns about the rise in growing numbers of children suicides and serious attempts of suicide. It was reported that in 2019 there have been 5 suicides in the county. The suicide prevention strategy is to be discussed at the next CDOP meeting and commissioning manager- public health and prevention will attend.

The CDOP will make enquires regionally and nationally to see if other areas are seeing a similar picture. What interventions are on-going and discuss a way forward.

Designated Doctors reported that the local flu vaccine take up rate in 2019 had been poor locally and as a result there had been a high number of attendances and admissions with flu. It has been identified that the late roll out of the campaign along with not enough vaccine's, inadequate mop up and parents wanting their children to have the injectable vaccine rather than the nasal one which was not available contributed to this poor takeup. This years immunisation newsletter and communications around flu vaccinations is planned to be rolled out by September and Public Health representative will link in with the communications team for safeguarding to enhance campaign material and distribution, and target identified areas of poor uptake.

Child Safeguarding Practice Review Group Update

The February meeting of the Child Safeguarding Practice Review Group (CSPR) on 12 February was chaired by Stephanie Nightingale, Designated Nurse for CCG, who takes over the role from Ros Negrycz, Designated Doctor for Safeguarding who retired from the group in January. This is a multi agency group consisting of statutory partners including education and representatives from the acute services, Royal Stoke UHNM etc.

In line with the new arrangements, the group have developed its Terms of Reference (ToR) which were approved at the meeting.

The focus of the group is predominately based on learning from the system and reviews, highlighting good practice as well as areas of improvement and it is the responsibility of the group to improve the system by integrating that learning so we can work together to keep children safe.

Moving forward the group will instruct a practitioners event to review the findings from five previous rapid reviews to add to the already extensive learning. These collective areas of process and similarities of circumstances will hopefully lead to better understanding and improved actions moving forward.

Practice, Development and Training Group Update

Following on from the merger of the two LSCB's into one Board, the training offer has now been revised as a way of consolidating the two previously separate functions of the Board. As a result of this, a new Practice, Development and Training Group (PDT) has emerged and is planning its priorities for the coming year, which includes revising our Working Together training and Child Protection Level one training. The forthcoming meeting on March 4, will see attendees asked to approve the revised Terms of Reference and work together to develop plans moving forward along with discussing proposals for training development sessions, training courses and dates for the coming year.

The training team will also be updating the group on the launch of its new Learning Management System (LMS) which is on track to go live on 1 April, giving access to both Stoke-on-Trent and Staffordshire courses and learning materials on one portal, and will include revised training packages, both face 2 face and elearning.

The LMS will be more user friendly with immediate access to courses and dates available at first site, making it easier to find the right course for you.

Booking courses will be available online once the new system goes live negating the need for paper forms and emails - more updates to follow.

SSSCB Conference 2020

SSSCB will be holding its annual conference on 17 March 2020 at Yarnfield Training Centre. The conference titled 'Child Criminal Exploitation' will include Vulnerable Adolescents and Adverse Childhood Experiences subject matter and has a great line up of speakers.

Dr Carlene Firmin, MBE, Principal Research Fellow at The International Centre will be speaking about her work into child sexual exploitation along with violence and trafficking. Also joining us with be Mark Gurrey from the National Child Safeguarding Practice Review Panel to talk about the National Panels first review into 'adolescents in need of State protection from criminal exploitation'.

There will also be a number of workshops discussing 'The vulnerability of the child' and the trauma behind the crime, Pathway Services, and a parents own story about the signs and behavioural indicators of County Lines.

Delegates attending must have undertaken Level One Child Protection Training and work with children and young people.
